8:30 A.M. The Board of Supervisors proceeded to canvass the results of the votes of the 2006 General Election for U.S. Representative for the 5th District, Governor / Lieutenant Governor, Secretary of State, Auditor of State, Treasurer of State, Secretary of Agriculture, Attorney General, State Senator for the 3rd District, State House of Representatives for the 5th and 6th Districts, three Court of Appeals Judges, two District 3A Court Associate Judges, and two District 3A Court Associate Juvenile Judge, were made and certified to the Secretary of State as provided by law. We hereby certify that 6,102 people voted in Clay County at the General Election on November 7, 2006.

The vote for said offices and the County, Township, and Soil & Water Conservation District Commission, Agricultural Extension Council Member offices, pursuant to Iowa Code Chapter 50.24, were tabulated and the results declared as set forth in the election records which, by this reference, is made a part of these proceedings.
